

SCI 2023 RECORD BOOK SHOTGUN SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING

Eligibility. Open only to active US or Canadian members in good standing of Safari Club International ("SCI" or "Sponsor") who are age 18 or older at time of entry and who are attendees at the 2023 SCI Annual Convention at the Music City Center in Nashville, TN ("Convention"). Employees of SCI and Safari Club International Foundation ("SCIF") and members of their immediate family or household are not eligible. Void in Quebec, Canada and where prohibited, taxed, or restricted. This Sweepstakes is conducted in the United States and is governed by applicable US law.

How to Enter. This Sweepstakes begins on or about 8:00 am Pacific Time (PT) on October 31, 2022, and ends February 25, 2023 at 1:00 pm Central Time (CT). ("Sweepstakes Period"). There are seven ways to enter the drawing: (1) submit an official Record Book entry for a Birds of the World entry to the SCI Record Book Booth in person in the foyer at the Convention and receive three numbered entry tickets into the drawing; (2) submit an official Record Book entry for any eligible record book entry, except the Birds of the World to the SCI Record Book Booth in person the foyer at the Convention and receive 1 numbered entry ticket into the drawing; (3) obtain one (1) free numbered entry ticket by hand delivering a 3 x 5 card with your legibly hand-printed name, address, age, and contact phone number to Sponsor's personnel at the SCI Record Book Booth in the foyer at the Convention; (4) access the SCI Record Book website at scirecordbook.org and follow the online instructions to submit an official Record Book entry for a Birds of the World entry online and receive three entries into the drawing; (5) access the SCI Record Book website at scirecordbook.org and follow the online instructions to submit an official Record Book entry for any eligible record book entry, except the Birds of the World, and receive one entry into the drawing; (6) obtain one (1) free entry by mailing a 3 x 5 card with your legibly hand-printed first and last name, street address (no PO boxes), age, and contact phone number in a postage pre-paid envelope to: SCI 2023 Record Book Shotgun Sweepstakes Entry, 4800 W Gates Pass Rd. Tucson AZ 85745, postmarked by February 25, 2023 and received by March 2, 2023. Limit one (1) entry per outer mailing envelope; or (7) Submit an entry to staff via email at rbsweepstakes@safariclub.org. Limit one entry per email. Each emailed entry must include "SCI 2023 Record Book Shotgun Sweepstakes Entry" in the subject line, and the body of the email must include the entrant's first and last name, street address (no PO boxes), age, and contact phone number. **For tax purposes, this is not a tax-deductible donation.** Each entry must be received during the Sweepstakes Period to be entered into the drawing, except that mail-in entries must be postmarked by February 25, 2023 and received by March 2, 2023. Limit 25 entries per person, regardless of the method of entry. Entrant assumes risk of loss, damage, destruction, delay, and misdirection of entries, and is solely responsible for illegible or incomplete entries. Once submitted, entries become the sole property of Sponsor and will not be returned. By entering, you agree to be bound to these official rules and the decisions of Sponsor which are final and binding in all respects.

Drawing. One winner will be selected in a random drawing conducted by Sponsor (or its authorized representative) on or about March 3, 2023, from all entries received. You do not need to be present to win. The drawing will be conducted by an SCI representative, whose decisions are final and binding in all respects. If a Canadian resident is selected in the drawing, he/she must correctly answer a skill-testing question in order to claim the prize. The question will be administered upon notification to the Canadian resident that he/she was selected. To receive the prize, the questions must be correctly answered without assistance of any kind, within a specified time limit.
